# LIMITED WARRANTY

Condenser Series: BAR7, BAH7 - Air Handler Series: LUC7, LCM7, CWM7, CHX7

**ComfortStar® USA** warrants that the air conditioning unit conforms to the manufacturers specifications and will be free of material defects and workmanship as listed and described below.

- The unit must be registered (except Quebec, CA Florida, USA and California, USA) within **sixty (60) days** of installation in a residential/multi family installation, the warranty covers all parts including the compressor and the coil for **ten (10) years** from date of installation to the owner of the property where the system was installed.
- The unregistered default warranty covers all parts including the compressor and coil for a period of five (5) years from installation to the owner of the property where the system was installed.

The replacement of a part or unit under this warranty does not extend the warranty period. ComfortStar® USA warrants a replacement part or unit only for the period remaining in the applicable warranty that commenced on the registered installation date.

This warranty period begins on the date of the original installation registered or verified by installation service receipt or invoice from contractor to customer. If the date cannot be verified, the warranty period begins **four (4)** months from the date of manufacture.

## **ComfortStar® USA Quality Replacement Assurance**

If the condenser coil, compressor or evaporator coil fails within three (3) years of original date of installation to the owner of the property where the system was installed. ComfortStar® USA will replace the unit, **one (1) time only with a new or equivalent unit.**
